

# CUPE NOVA SCOTIA HIGGINS INSURANCE SCHOLARSHIP



**CUPE Nova Scotia Higgins Insurance Scholarships** are awarded by CUPE Nova Scotia. Two scholarships valued at \$1000.00 each are available annually.

**Individuals** planning enrollment at an accredited post-secondary institution in the 2017-2018 academic year may make application. The successful applicant will be required to provide proof of registration.

Eligibility:

- 1. Union members in good standing with a local union affiliated to CUPE Nova Scotia; and,
- 2. Sons, daughters, or legal wards of a member in good standing of a local union affiliated to CUPE Nova Scotia.

**Basis of awards** shall be the applicant's financial need and current and ongoing volunteerism/social activism in his/her community.

Application must be complete and on the prescribed form and must be received by the CUPE Nova Scotia Scholarship Committee not later than Feb15<sup>th</sup> 2017. Supporting documents must be provided with the form in order for the application to be considered.

**Decisions** of the CUPE Nova Scotia Scholarship Committee will be final. CUPE Nova Scotia assumes no responsibility for applications or supporting documents lost, misdirected, or otherwise not received by the deadline. It is the applicant's sole responsibility to ensure that the application is made correctly, legibly and in a timely manner. Late submissions will not be considered. Consideration will be given to first time recipients.

**Confidentiality:** Member data is highly confidential and must be treated as such. Members of the Higgins Insurance Committee confirm that they will at all times keep confidential the affairs of the membership. The names of the successful applicants may be published in official publications and/or web site of CUPE Nova Scotia and Higgins Insurance.
